2. **Declaration of Interest –**
Cllr. Gwilym O. Jones and Gordon Owen declared a personal interest in item 4.3 Caergeiliog, Village Hall.
3. **Minutes of the previous meetings**

4. **Matters arising from the minutes.**
 - 4.1 Playing Field: S. Wharton had cut the park and RoSPA had produced a report on the state of the equipment. There were no serious concerns but it had been noted that there were minor trip hazards because of the gaps in the safety mats. The clerk would circulate the report and look at creating a maintenance plan.
 - 4.2 Defibrillator – IOACC were happy to install either of the two options put forward by the Community Council for attaching the defibrillator. Having discussed the merits of each it was agreed to use the cheapest option i.e. the galvanised post. This would also accommodate appropriate signage.
 - 4.3 Village Hall: The draft lease had been circulated, there were no matters of concern – the Chairman and Clerk would report back to the solicitors so that the transfer could be finalised as soon as possible. Members were also reminded that the Council had agreed to pay all legal costs for the setting up of the Lease Agreement.
 - 4.4 Footpaths: The work on footpath 21/004/1 by St Mary's Church was complete. Cllr. Dyfed Williams would check the footpaths during the summer and advise on a new work specification for the tender process.
